Members who check with their own insurance agents will note that these premiums are exceptionally low and an excellent bargain.

Fidelity Bond Insurance covers theft of club funds by a BetterInvesting dues-paying club member in the BetterInvesting dues-paying club. Both the club and the club members must be dues-paying members of BetterInvesting at the time of the theft.

We must have a committee of members conduct and preserve in club records an annual verification of club records as outlined in Chapter 9 of BetterInvesting's *Club Accounting Manual* or the Club Accounting Software audit guidelines and must report any loss within one year of its occurrence. For your convenience, a printable annual verification form is on the website at <u>www.betterinvesting.org/verification</u>. The audit is not generally completed until February of the following year and need not be completed prior to applying for bonding insurance.
