OLC Portfolio 2022-2023 Contest

Since January 10th, the drafting of the last report on the Portfolio Contest, the market has risen nicely. For the fourth month in a row, the average value of Contest Portfolios increased even more than the S & P Index, beating it 5.9% to 3.4%. Bravo to the OLC BetterInvesting contestants and to the BetterInvesting investment philosophy. In terms of standings, the Prairie Investment Partnership jumped ahead of the Yankee Model Club to have the top valued portfolio. All six of Prairie Investment Partnership's holdings are up (Enghouse Systems, Topgolf Callaway Brands Corp, GFL Environmental, Maximus, Skechers USA, Encore Wire) since the contest began, with their top gaining stock, Maximus, up 38.6%.

Since the last report, the stocks having the greatest increase in share price were Tesla (up 66 percent) and Nvidia (up 33 percent).

Entrants can change their holdings once during the contest. The close of the market on Friday, February 17 will be the deadline for submitting requests for changes and prices at that time will be used as the share values for the changes made. Entrants can sell all or part of specific holdings to buy new holdings (max portfolio size = 7 holdings) or add to existing holdings. The amount available for reinvestment will be the amount received from sales.

This year's contest will run through July 31, 2023. Anytime during this period the entrants, their portfolios, and their standings can be viewed by clicking on Portfolio Summary and Portfolio Details. Periodic updates on the progress of the Portfolios will be published in our monthly Bulletins.
