Some highlights:

Online chapter is the largest chapter with over 3000 members, 379 clubs, two online model clubs, spread over 35 states and territories. We have a great team of 26 volunteers that also include three BIVAB Directors on our team.

This year's accomplishments were summarized highlighting our successes in supporting OLC Members and Clubs with focused Education Programs, Supporting and Responding to Membership needs, enhancing Communication with Clubs and Members, and continuing to enhance education with a selection of Best of the Class webinars from a review of the BI video archive library.
