OLC Portfolio 2022-2023 Contest

Since February 10th, the drafting of the last report on the Portfolio Contest, the market has dropped 4.5 percent and the average of the contests' portfolios has dropped somewhat more, 6 per cent. For the second month in a row, the Prairie Investment Partnership has the leading portfolio with the Two Rivers Club moving from sixth to second in the rankings. Five of the Two Rivers Club's six stocks gained during the month (Enghouse Systems Ltd, Topgolf Callaway Brands Corp, GFL Environmental Inc, Maximus Inc, Skechers USA Inc, Encore Wire Corp) and the share price of the sixth dropped only minimally (1 percent = 25 cents). In terms of individual stocks, the biggest gainers were XLMedia PLC, up 34 percent, held in Timur Yildiz' portfolio, and Zynex, up 32 percent, held by the Yankee Investment Club.
