Al for All: A Smarter Approach to Investing and Everyday Life

This year's annual meeting took a bold and timely turn as we stepped into the world of Artificial Intelligence with our featured session: Al for All. Whether you're an early adopter or just Al-curious, the goal was simple: demystify Al and show how it can empower everyday investors, learners, and lifelong explorers.

Why AI? Why Now?

Artificial Intelligence isn't coming—it's already here. From the Netflix shows you're recommended to the navigation apps you rely on, AI is woven into our daily lives.

Our session provided members with the opportunity to pull back the curtain and gain insight into how AI thinks, where it excels, and where it still requires a guiding human hand.

We tackled common myths and limitations, explored privacy risks, and shared *practical ways to use Al intentionally*, not just as a curiosity, but as a tool for productivity, creativity, and financial insight.

Members learned that *prompts* are the key to communicating with AI. By refining questions and providing AI with the right context, we can transform vague output into actionable insights. We explored real examples from meal planning to market research—yes, AI can help you cook dinner *and* compare stocks!

Using Al for Smarter Investing

We walked through how AI tools like ChatGPT and Microsoft Copilot can:

- Summarize earnings calls
- Compare companies side-by-side
- Identify red flags in financial reports
- Research long-term trends and ETF opportunities
