Reflecting on the Journey

Q: What inspired the founding of your investment club 20 years ago, and how has the vision or mission evolved over the years? A: The inspiration for PI3 came from two other investment clubs formed by Sorority Sisters in our chapter. Seeing their vision for building wealth through collective investing motivated us to create our club-one where we could cultivate learning together while earning in the new century.

Key Lessons Learned

Q: What are the most significant lessons the club has learned about investing and teamwork over the past two and a half decades?

On teamwork, we took a valuable tip from Harvard Business Review's article,

'Support Your Learning with a Community':

"We're born with a natural curiosity. We want to learn. But the demands of work and personal life often get in the way. The solution is to make learning a lifelong habit, and to do that, you must be proactive. Start by articulating the outcomes you'd like to achieve. Selecting one or two outcomes will enable you to set achievable goals, helping the habit to stick. Next, find or create a group that shares similar interests to make achieving them more fun."

Adaptation and Growth

Q: How has the club adapted to changes in the financial markets and investment landscape, such as the rise of technology, shifting economic trends, or unexpected events like the 2008 financial crisis?

A: We adapted by staying flexible and intentional in our strategies. During events such as the 2008 financial crisis, we emphasized the importance of patience, diversification, and maintaining a long-term perspective, rather than reacting impulsively.

As technology transformed investing, we integrated new research platforms and virtual tools to stay informed and A: The most significant lesson learned was to set achievable goals connected. By monitoring economic trends, we adjusted sector allocations and broadened our knowledge to capture emerging opportunities while managing risk. Our structured strategy, achievable goals, and collective learning have kept us resilient through change.

Celebrating Milestones

Q: What are some of the club's most notable achievements or proudest moments during its 20-year history?

A: Reaching a portfolio value of over \$200,000 was a major milestone. A particularly proud moment came at our 10th Anniversary, when we honored a beloved member who had gained her wings with a commemorative painting entitled 'The Lesli.'

TERMS TO GROW BY...

BID-ASK SPREAD

The bid-ask spread is the difference between the highest price a buyer is willing to pay (the bid) and the lowest price a seller is willing to accept (the ask) for a security. It represents a key component of market liquidity and trading costs. A narrow spread typically indicates a highly liquid market with many buyers and sellers, while a wide spread may signal lower liquidity or higher volatility. Understanding this is crucial because it directly affects trading costs. Investors may pay more or receive less due to wide spreads, especially in low-volume or volatile stocks.



CAPITAL EXPENDITURES (CAPEX):

Capital Expenditures (CapEx) refer to the funds a business uses to purchase, upgrade and maintain physical assets, including property, plants, buildings, technology and equipment. These investments are typically long-term and help improve the company's production capacity or efficiency. CapEx is crucial for stock investors because it reflects a company's growth strategy and its potential for future earnings. Large, well-managed capital investments can increase revenue, making the company more valuable. Conversely, excessive or poorly planned CapEx may indicate financial risks or inefficiency.
