Don't Miss Our September Meeting & Speaker: Paul Merriman on 'The Ultimate Buy and Hold Portfolio — On Steroids!'

Saturday, Sept. 11, 9-11:30 a.m., Online

The chapter's monthly Board of Directors meeting in September will be preceded with a special presentation from **Paul Merriman, nationally recognized authority on mutual funds, index investing, asset allocation and both buy-and-hold and active management strategies.**

Paul will discuss the 10 best performing equity asset classes and the impact of combining the best of the 10 into smaller portfolios. He will offer a list of Best in Class ETFs and mutual funds investors could use to build these portfolios. He will also introduce a custom calculator investors can use

to build hypothetical returns of these equity portfolios (combined with different levels of fixed income investments) during the accumulation and distribution stages of life.

Al Valencia Honored with Chapter's 2021 Blue Chip Award



Three years ago, the Puget Sound Chapter faced a difficult decision: many of the volunteers who had organized the chapter's premier annual event, the Investors Education Conference, were burned out after years of planning the conference. The board announced that without new help, the event might not be held in 2019. Soon after, Al Valencia stepped up and chaired a very successful and well attended IEC in 2019.

Al signed on as chair again in 2020, and soon was figuring out how to offer our first online IEC, due to the Covid-19 pandemic. It was a job that required creative thinking and thoughtful leadership. Success again! Four online classes drew not only chapter members but BetterInvesting members from around the country. And Al is chairing this year's IEC too, expanded to six online classes.

Al is a person who steps up to the plate when a big job needs to be done, again and again. And he does it with detailed organization and an infectious enthusiasm that fires up the rest of the planning committee.

For Al's tireless efforts in organizing three consecutive IEC's, he will be honored with the 2021 Blue Chip Award for outstanding service to our chapter.



Al joined BI in 2002, took classes, and joined two investment clubs, serving as president and secretary for both for many years. He became a Puget Sound Chapter volunteer in 2016, serving first as class coordinator for the IEC. He has since become an indispensable member of the board of directors.

Al lives in Bremerton and has hosted virtual as well as in-person meetings for the Kitsap Special Interest Group

on many investing topics.

Al is an active volunteer in his community as well, including with Kitsap Greater Give and Kitsap Computing Seniors, which teaches computer skills and refurbishes and donates computers to people in need. He was active in his children's schools, serving on the PTA, and many committees and projects with the Central Kitsap School District (CKSD). He has twice been recognized at CKSD with the highest volunteer honor, the Golden Acorn Award. He has served as Royal Ranger Commander at Hillcrest Assembly Church, and board member for the YMCA and Sports Beyond. For more than 20 years Al coached club and high school basketball.

Al is a carpenter who owned his construction business before retirement. He loves to travel and will finally be able to attend the BetterInvesting National Convention this year. He manages his wife's and children's retirement portfolio while guiding them in understanding investing.

Our chapter board and volunteers feel fortunate to know Al and have him working with us.

Tuesday, November 9, 7-8 p.m.

Technical Tools for the Fundamental Investor

Fundamental investors can use technical analysis to their advantage. Learn how to protect your profits and gain insight into the "attitude" of the market and your company. Discover how to measure and use price volatility to help make decisions, how to set a five-year low price, as well as how to obtain confirmation when the price is getting "frothy"—and what to do about it. Discounted Cash Flow

Without knowing what a stock is worth, how can you know how much you should pay for it? This presentation will show you how to accurately estimate the intrinsic value of a business, an indispensable starting point for reliably successful investing. Having an intrinsic value, or margin of safety estimate, keeps you focused on the value of the business, rather than the price of the stock – and that is what you want, because as an investor, you are buying a small piece of a business. Centering Your Stock Portfolio Management

While analyzing and selecting stocks are vital parts of successful investing, they are just the beginning. How well you manage your "team" of stock holdings is what ultimately determines your success. In this class, Cy shows why focusing on the potential impact that a specific buy, hold or sell decision will have on your overall portfolio is better than just looking at a single stock in isolation. He'll then use practical examples to demonstrate how this portfolio-centered decision-making methodology can simplify your investment decisions and take emotion out of portfolio management, especially the dreaded decision to sell. Alternative Investments to Lower Downside Risk

Learn the basics of some alternative investments designed to lower the downside risk in your portfolio. We will look

at dated bond funds, both taxable and municipal, that diversify your bond holdings yet free you from much of the bond research. We will look at buffered exchange-traded funds (ETFs) designed to absorb the first 5-30% of market downturns during the life of the ETF yet giving you upside growth. Why might you consider these as opposed to buying individual stocks or stock funds? Let's look at their risks and their advantages. Instructor: Christi Powell

Situational Options Strategies

Options may seem complicated at first and unsuitable for long-term investors, but their flexibility becomes apparent once you grasp the basic building blocks.
